District /CAL FIRE Chief Report for July 2016

EMERGENCY ACTIVITY

1. Station 15 - South Bay responded to 96 calls in July with 7 Simultaneous Calls (Back to Back). Two of the Simultaneous Calls required Advanced Life Support (1st: 1, 2nd: 1, Both: 0). Of these 96 incidents, 77 were Medical Calls with 50 requiring Advanced Life Support provided by Paramedics; A CAL FIRE Firefighter rode in to the hospital with SLO Ambulance one time during the month of July. One call required Staging; Five incidents were reported as Traffic Collision; Three incidents were reported as Fire, 15 as Public Service Assists, and one as Emergency.
2. Company 15 was called to cover the station or respond to emergencies in the month of July a total of seven times.

ADMINISTRATION

3. On April 17, 2016 Medic Engine 215 was sent to the Emergency Vehicle Group in Anaheim for mechanical and electrical issues and remained in the shop throughout the month of May, June and July. While Medic Engine 215 was in the shop, SLO County Medic Engine 212 was assigned to Station 15 - South Bay to maintain two vehicles for emergency response.
4. From July 13-16, 2016 the Command Vehicle (B-3411) went out of service to have the wheel bearings replaced, along with the Code-3 Controls. It was taken to the CAL FIRE North County Shop and repaired at no cost to the District.

SPECIAL PROGRAMS/PROJECTS

5. During the month of July, Staff began preparations for the upcoming Fire Safety Fair that is scheduled to take place on Saturday, October 8, 2016 from 11am-3pm in the Rite-Aid Parking Lot. This annual event includes tours of the Fire Engines, a true-to-life training in the SLO County Firehouse that teaches children to get low, get out and call for help when they see smoke indoors, demonstrations by SLO Ambulance, SLO County Sheriff's Office, the Estero Bay Community Emergency Response Team (CERT), the Los Osos Focus Group. In addition, Station 15 – South Bay will demonstrate auto extrication techniques using the jaws of life and children can try there hand at our Extinguisher Flash Pan booth or conduct a cliff rescue to save a teddy bear. Come out and meet Smokey Bear and participate in our Stamp Station Game for free homemade baked treats.

FIRE PREVENTION

6. From July 1 through July 5, 2016 Station 15 – South Bay Staff and Reserve Firefighters conducted second inspections on the 489 original lots found in violation of the fire code. In total, 117 violations remained (Vegetation Violations: 96, Address Violations: 19, Multiple Violations: 11) and notices were sent to the property owners. They were given two weeks to correct the violations.

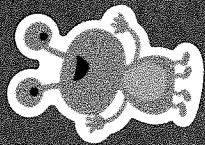

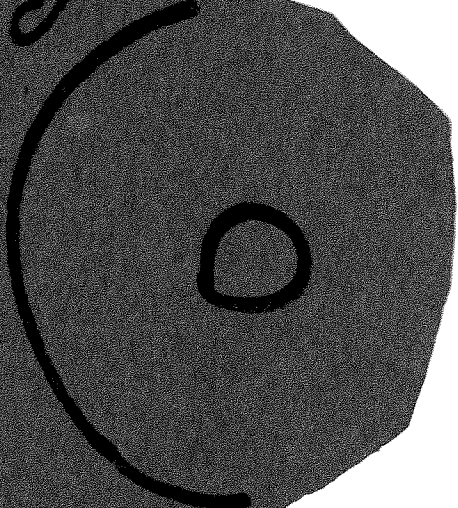
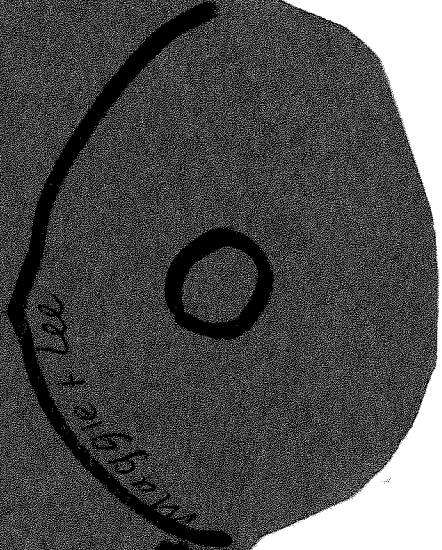
