District /CAL FIRE Chief Report for August 2021

EMERGENCY ACTIVITY

1. Station 15 - South Bay responded to 158 calls between July 22 – August 21, 2021 including 88 Medical Aids, and 20 Traffic Collisions; 20 incidents were reported as Fire, 2 as Hazardous; 17 as Public Service Assists; and 11 as False Alarms. Company 15 was called to cover the station or respond to emergencies 2 times between July 22 – August 21, 2021.
2. Station 15 – South Bay continues to respond during the COVID-19 pandemic. Crews are taking extra precautions to limit exposure during medical calls.

SPECIAL PROGRAMS/PROJECTS

3. During the last week of August, Battalion Chief Paul Provence went to South Dakota to inspect the new ME15.
