EMERGENCY ACTIVITY

 Station 15 - South Bay responded to 157 calls between October 22, 2022 – November 21, 2022, including 95 Medical Aids, 24 Traffic Collisions; 3 incidents were reported as Fire, 2 as Hazardous; 26 as Public Service Assists; 1 Vegetation management; and 6 as False Alarms. Company 15 was called to cover the station or respond to emergencies 5 times between September 22, 2022 – October 21, 2022.
