District /CAL FIRE Chief Report for December 2014 and Annual 2014

EMERGENCY ACTIVITY

1. Station 15 - South Bay responded to 131 calls in December with 8 Simultaneous Calls (Back to Back). Five of the Simultaneous Calls required Advanced Life Support (1st: 1, 2nd: 1, 1st & 2nd: 3). Of these 131 incidents, 95 were Medical calls with 52 requiring Advanced Life Support provided by Paramedics; A CAL FIRE Firefighter rode in to the hospital with SLO Ambulance one time during the month of December. Zero incidents were reported as Traffic Collision; Three incidents were reported as Fire, 26 as Public Service Assists, and seven as Emergency.
2. Company 15 was called to cover the station or respond to emergencies in the month of December a total of ten times.
3. Station 15 - South Bay responded to 1252 calls in 2014 with 85 Simultaneous Calls (Back to Back). 42 of the Simultaneous Calls required Advanced Life Support. Of these 1252 incidents, 864 were Medical calls with 463 requiring Advanced Life Support provided by Paramedics. 42 incidents were reported as Traffic Collisions; 72 incidents were reported as Fires, 255 as Public Service Assists, 61 as Emergency, and 130 with Code 2 Response.
4. Company 15 was called to cover the station or respond to emergencies in 2014 a total of 119 times.

ADMINISTRATION

5. During the month of December, one (of the six) Station 15 – South Bay Reserve Firefighter candidates successfully registered on his own accord to attend the Firefighter I Academy at Allan Hancock Community College. This Academy offers an equivalent in training and skills and is attended at the cost and discretion of the candidate. The remaining five applicants will require the 48 hours of minimum training, as they received all other necessary training courses prior to being hired. All six candidates also successfully registered to attend the Initial Diablo Canyon Course. This eight hour, onsite course provides an overview of plant operations, essential systems, potential accident scenarios, and other important information when responding to the Diablo Canyon Power Plant.
6. During the month of December, a local citizen made a monetary donation to the Alisa Ann Ruch Burn Foundation (AARBF) in honor of Station 15 – South Bay (see attached card from AARBF).
7. On December 1, 2014 Station 15 – South Bay staff submitted an application for the 2014 Federal Emergency Management Agency - Assistance to Firefighters Grant requesting about \$55,000 in funding to provide 25 full sets of Fire Personal Protection Equipment, along with an electric security gate to be purchased and installed at the Station 15 – South Bay parking lot. If successful, Fund 301 will be required to contribute five percent of this amount, or about \$2700 as its match to the request. Station 15 - South Bay staff has been in contact with Congresswoman Capp's office, as well as Senators Boxer and Feinstein to solicit their support.
8. On December 31, 2014, Reserve Firefighter Eric Gardley resigned in good standing from Station 15 – South Bay with 1.5 years of service after receiving a full-time Firefighter position with the Bakersfield Fire Department. Eric was a loyal and hard-working member of this Department and Station 15 Staff is proud to see him advance in his career.

TRAINING

9. From December 15-17, 2014, Fire Captain – Paramedic Peterson, Fire Apparatus Engineer - Paramedic Green and Firefighter II – Paramedic Brannen along with about 25 other CAL FIRE employees attended a 24 hour Continued Professional Training course taught by CAL FIRE/SLO County Fire Department Training Staff . This course provided an opportunity for annual certification maintenance including CPR, a Rescue Systems 1 (moving large objects) and Air Ambulance/Rescue Helicopter class as well as 8 hours of Hostile Shooter training in cooperation with local law enforcement agencies from SLO County. This is the first of 4 mandatory 24 hour annual training sessions for all CAL FIRE personnel.

SPECIAL PROGRAMS/PROJECTS

10. Throughout the month of December, Station 15 – South Bay, in cooperation with KSBY Television and the San Luis Obispo County Firefighters Benevolent Association continued with Operation Santa Claus and the Season of Hope charity events. Operation Santa Claus provides unwrapped presents to needy children under the care of San Luis Obispo County Child Protective Services and the Season of Hope provides food and toys to local Food Banks and Toy Agencies.

SPECIAL PROGRAMS/PROJECTS

11. On December 16, 2014 Chief Veneris and Fire Apparatus Engineer – Paramedic Borja attended an Estero Bay Community Emergency Response Team meeting at Station 53 – Morro Bay Fire Department. This meeting consisted of an annual review of CERT activities, a training drill for emergencies and an opportunity for participants from Los Osos, Morro Bay and Cayucos to interact in a social setting.

FIRE PREVENTION

12. On December 10, 2014, CAL FIRE Apparatus Engineer – Paramedic Teddy Borja was the guest of honor at the Los Osos Kiwanis Club Meeting held at Jimmy Bump’s Pasta House. Engineer Borja spoke to the guests regarding all aspects of safety in the home, including fire, medical, water/gas and trench. Kiwanis and Los Osos Valley Mortuary sponsored the lunch for the two Firefighters in attendance.

13. On December 13, 2014, Station 15 - South Bay attended the Los Osos Holiday Parade. Medic Engine 15, Medic Rescue 15, Engine 215, Utility 15, and Boat 15 all represented Station 15 - South Bay with their family and friends, including Smokey Bear and Sparky the Fire Safety Dog.
