District /CAL FIRE Chief Report for August 2020

EMERGENCY ACTIVITY

1. Station 15 - South Bay responded to 129 calls between July 22 – August 21, 2020 including 80 Medical Aids, and 8 Traffic Collisions; 10 incidents were reported as Fire, 4 as Hazardous; 17 as Public Service Assists; and 10 as False Alarms.

Company 15 was called to cover the station or respond to emergencies 1 times between July 22 – August 21, 2020.

2. Station 15 – South Bay continues to respond during the COVID-19 pandemic. Crews are taking extra precautions to limit exposure during medical calls. Station 15 – South Bay is still closed to the public for non – emergency visits.

FIRE PREVENTION

3. During the month of August, Station 15 – South Bay staff continued working with lots within the District for violations to the Hazardous Vegetation Ordinance. In total there are 2 final properties that have not been compliant.
4. During the month of August, Station 15 – South Bay staff conducted business inspections in the District. This is an ongoing project that continues throughout the year.

SPECIAL PROGRAMS/PROJECTS

5. On August 8-9th, 2020 Station 15 – South Bay hosted an in-house academy for our newly hired Reserve Firefighters. Our new Reserves who are now working shifts are Bradford Dunn, Jeffery Leazer, Andrew McCorkle and Noah Miller.
