My husband and I had to dig a new deeper well a couple years ago as did our surrounding neighbors. It's no fun to discover one day that your trusted water supply is drying up. This happened to us once and we'll do everything in our power to prevent it from happening again. We beg you to vote for site E.


To LOCSD Board Members, Administrative Service Manager to the Board and to the General Manager:

Dear Mr. Munds,

I understand the Los Osos Community Services District (LOCSD) is proposing to construct a community water supply well on District owned property at the northwest corner of Bay Oaks Drive and South Bay Blvd. My firm represents the adjacent property owner to the north, Leon Van Beurden. As the most immediate neighbor to the proposed project, my client has concerns and wishes to communicate them to you in advance of your Board's consideration of the project on November 5, 2020.

Fundamentally, we support the proposed project as an important infrastructure asset to assist in managing the Los Osos Groundwater basin for the community. With you and your Board's cooperation, I am sure we will be able to reach a mutually agreeable framework moving forward.

My client's greatest concern relates to the planned construction of a boutique hotel which will complement the balance of the commercial complex owned by Mr. Van Beurden. Please see the graphic depiction below of the proposed hotel (in red) location in close proximity to the proposed water well location.

The blue circle reflects the proposed location of the well. The first request is that the well location be shifted approximately 50 feet to the south to achieve additional separation between the hotel and your facility. Please see the green box, which is intended to reflect the more desirable location. We understand this may require the excavation of one of more of the decommissioned septic tanks. Clearly, if the LOCSD had known the Bay Oaks site was going to be used for a well, it would have removed the tanks during decommissioning, instead of abandoning in place. It would appear removal of some or all the tanks would also better facilitate the construction of myriad connection and transmission pipes needed for the well facility.

The following is a list of additional concerns and requests.

- 1. Access to the facility is taken from Bay Oaks Dr.
- 2. The well and pump house be constructed of masonry block for maximum sound attenuation and pleasing architecture.
- 3. No nitrogen removal facilities are added.
- 4. No backup power generation is added.
- 5. No storage or clutter.
- 6. Attractive fence detail and landscape.
- 7. Allay any concerns about future subsidence from over pumping.

We understand the proposed well is intended to look and function similar to the Golden State Water Company facility on South Bay Blvd. north of Los Osos Valley Road. Please see the ground level photos below of these existing facilities. Mr. Van Beurden's expectation is that the LOCSD's proposed project appears similar.
