Approve Purchase of Zoll Heart Monitor

DESCRIPTION:

This Staff Note requests permission to purchase new equipment for Station 15 – South Bay Paramedics including one Zoll X Series Manual Monitor/Display and supporting equipment.

STAFF RECOMMENDATION:

Staff recommends that the Board adopt the following motion/resolution:

Motion: I Move to Direct Staff to Purchase One Zoll X Series Manual Monitor/Display with Supporting Equipment from the FY 2019/2020 Fund 301 Budget.

DISCUSSION:

Station 15 – South Bay is required to have a total of three heart monitor/defibrillators for use by its paramedics (2 front-line and one backup). Staff has made purchases over the years to meet this requirement. Zoll Monitors are the industry standard in San Luis Obispo County, and therefore the only vendor used by paramedic providers in SLO County.

The LOCSD-owned 2011 E Series Zoll Monitor is past its warranty and lacking technology that has become the standard of care in San Luis Obispo County, such as side-stream capnography, 12-lead telemetry, compatibility with electronic patient care reporting and more. Staff has received a bid from Zoll for the purchase of a Zoll X-Series ECG Monitor/Defibrillator to replace the obsolete E-Series. The bid received by CAL FIRE Staff for the new monitor utilized the bulk discount pricing granted to *CAL FIRE*. Our savings is approximately \$7,200; total price is \$36,663.15.

FINANCIAL IMPACT:

Staff has designated the necessary funds for this purchase in Line Item 7238-Paramedic & EMT Small Tools, not to exceed \$36,663.15.
