Adopt Resolution Declaring Medic Rescue-15 Vehicle Surplus to District Needs and Authorize

the Sale of Surplus Vehicle

DESCRIPTION

This staff note requests your Board declare Medic Rescue-15, a 2004 Ford F550 4WD with a Ferrara Fire Apparatus Rescue Equipment Storage Build Up surplus to Station 15 – South Bay and sell it to the highest bidder and deposit the proceeds into Fund 301 Line Item 9504, Vehicle Replacement Reserve.

STAFF RECOMMENDATION

Staff recommends that the Board adopt the following motion/resolution:

Motion: I move that the Board adopt Resolution 2018-22 declaring Medic Rescue-15, a 2004 Ford F550 4WD with a Ferrara Fire Apparatus Rescue Equipment Storage Build Up, surplus to Station 15 – South Bay, and to direct staff to sell it to the highest bidder and to deposit the proceeds into Fund 301 Line Item 9504, Vehicle Replacement Reserve.

DISCUSSION

In May 2016, the status of the Medic Rescue-15 was discussed in detail at an Emergency Services Advisory Committee Meeting. This discussion included statistics that proved the Medic Rescue had been out-of-service due to persistent mechanical and electrical issues, at a cost of \$33,000. ESAC voted unanimously to recommend to the LOCSD BODs that they approve the necessary funds for the purposes of replacing this vehicle.

In March 2017, your Board adopted Resolution 2017-10 authorizing the purchase of a replacement Medic-Rescue Vehicle.

In March 2018, the new Medic Squad 15 was received. It has been equipped with all of the proprietary emergency equipment. As the primary response engine to MDO, this new vehicle seats 4 people and is equipped with Advanced Life Support and Rescue equipment that will serve the community for many years to come.

In April 2018, the Medic Squad 15 arrived at the CAL FIRE/SLO County Fire Department Shop where staff began installing medical equipment and firefighting gear on the engines.

In June 2018, Station 15 - South Bay staff began advertising Medic Rescue-15 in on-line fire engine advertising agencies and print magazines. Research by CAL FIRE and Station 15 - South Bay staff, as well as guidance by multiple advertising agencies indicated that Medic Rescue-15 had a market value of \$25,000 to \$35,000. The advertising vendors charged various amounts, ranging from 5% to 8% for securing a purchaser. Station 15 – South Bay staff chose to start the bidding at \$30,000.

To date, one serious inquiry has been made.

FINANCIAL IMPACT

Staff has been anticipating the sale of Medic Rescue-15 since your Board's approval of the purchase of a new Medic Squad. CAL FIRE/Station 15 – South Bay Fire Staff expects to deposit any proceeds from the sale of Medic Squad-15 into the Fund 301 Vehicle Reserve, Line Item 9504.
