District /CAL FIRE Chief Report for July 2020

EMERGENCY ACTIVITY

1. Station 15 - South Bay responded to 161 calls between June 22 – July 21, 2020 including 82 Medical Aids, and 22 Traffic Collisions; 19 incidents were reported as Fire, 1 as Hazardous; 22 as Public Service Assists; and 15 as False Alarms.

Company 15 was called to cover the station or respond to emergencies 3 times between June 22 – July 21, 2020.

2. Station 15 – South Bay continues to respond during the COVID-19 pandemic. Crews are taking extra precautions to limit exposure during medical calls. Station 15 – South Bay is still closed to the public for non – emergency visits.

FIRE PREVENTION

3. During the month of July, Station 15 – South Bay Firefighters inspected lots in the District for violations to the Hazardous Vegetation Ordinance. In total, 11 final violations were found.
4. During the month of July, Station 15 – South Bay staff conducted business inspections in the District. This is an ongoing project that continues throughout the year.

SPECIAL PROGRAMS/PROJECTS

5. During the month of July, Station 15 – South Bay hired four reserve firefighters. During the month of July, we will continue the hiring process for these individuals by having them work shadow shifts with our current staff and attend and In-House Academy.
