	General Manager Munds commented that discussions are beginning held regarding what opportunities are available for the District; that he is a member of CWAT; that any water received would need a drought buffer to put water into reserve and a mechanism that new development would need to pay for that infrastructure and water separately; provided an estimate time frame of 5 years for an intertie versus a desalinization project being 10+ years. Chairperson Cesena commented on the complexities of getting additional water supply and how the District will handle it; on a maximum cap on what the basin can supply. Public Comment — Jeff Edwards commented that the County has a residential maximum growth rate and that the Community Plan is incorporating a lower growth rate in their plan; that Los Osos needs to get water resources and the growth rate will take care of itself.
