District /CAL FIRE Chief Report for December 2017**

EMERGENCY ACTIVITY

1. Station 15 - South Bay responded to 116 calls in December, including 65 Medical Aids; 10 incidents were reported as Fire; 22 as Public Service Assists.
2. Company 15 was called to cover the station or respond to emergencies in the month of December a total of four times.

ADMINISTRATION

3. On December 14, 2017, Station 15 – South Bay held interviews for a 15-hour Office Assistant. We are proud to welcome Holly Rohner as the newest member to Station 15 – South Bay. Holly has an extensive background in finance and event planning. She has a passion for working in environments where she can positively affect her community. She is a great asset to our Station and to Los Osos!
4. The eight prospective Station 15 – South Bay Reserve Firefighter candidates continued completing steps needed to become employees of the LOCSB. In December, all of the candidates successfully completed a medical evaluation and were cleared by a doctor to be Fit Tested for Self-Contained Breathing Apparatus as required by OSHA as well as to work for the LOCSB. Each candidate was issued a department uniform and personal protective equipment (turn-outs).

SPECIAL PROGRAMS/PROJECTS

5. During the month of December, Station 15 – South Bay, in cooperation with KSBY Television and the San Luis Obispo County Firefighters Benevolent Association continued the Operation Santa Claus and the Season of Hope charity events, providing unwrapped presents to needy children under the care of San Luis Obispo County Child Protective Services and the Season of Hope provides food and toys to local Food Banks and Toy Agencies.

SPECIAL PROGRAMS/PROJECTS

6. On December 9, 2017, Station 15 - South Bay attended the Los Osos Holiday Parade. Medic Engine 15, Medic Rescue 15, Engine 215, Utility 15, and Boat 15 all represented Station 15 - South Bay with their family and friends.
7. The Annual Needs 'N Wishes Holiday Fundraiser, sponsored by South Bay Seniors People Helping People, collected 8 barrels of new toys to assist in the SLO Firefighters Benevolent Association's Operation Santa Claus Project. Our sincerest appreciation and thanks for all of their great work in our community!

8. On December 8, 2017, Executive Assistant Harmony Brown attended the Quarterly Meeting for the Cal Chiefs Administrative Fire Services Section in Pismo Beach where SLO County Fire Safe Council Business Manager Dan Turner (retired SLO County Fire Chief 2006) provided a presentation on workplace communication, healthy ways to process stress and resources to assist in these areas.
